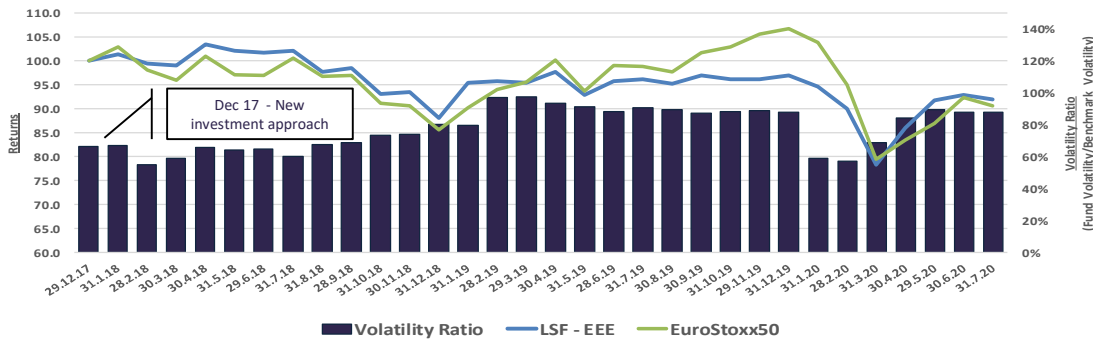

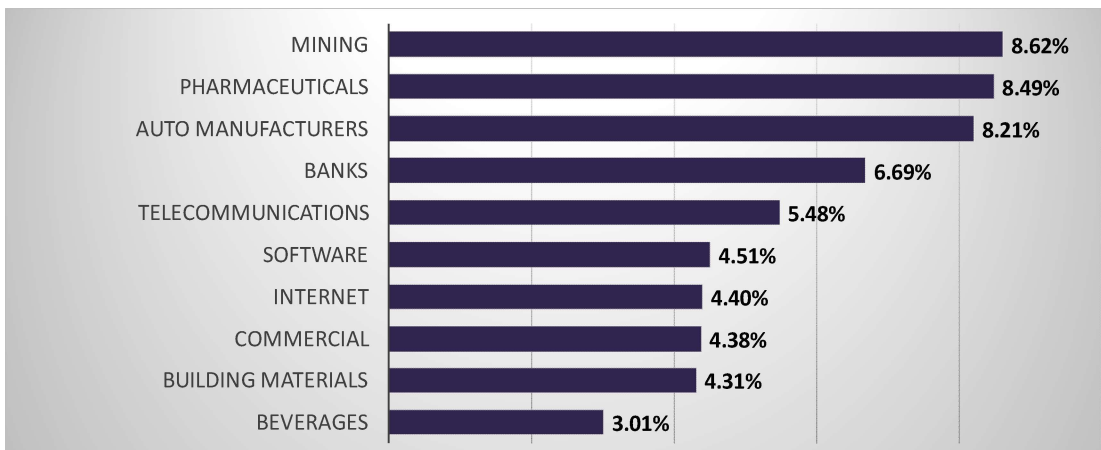

Risk Profile (SRRI)

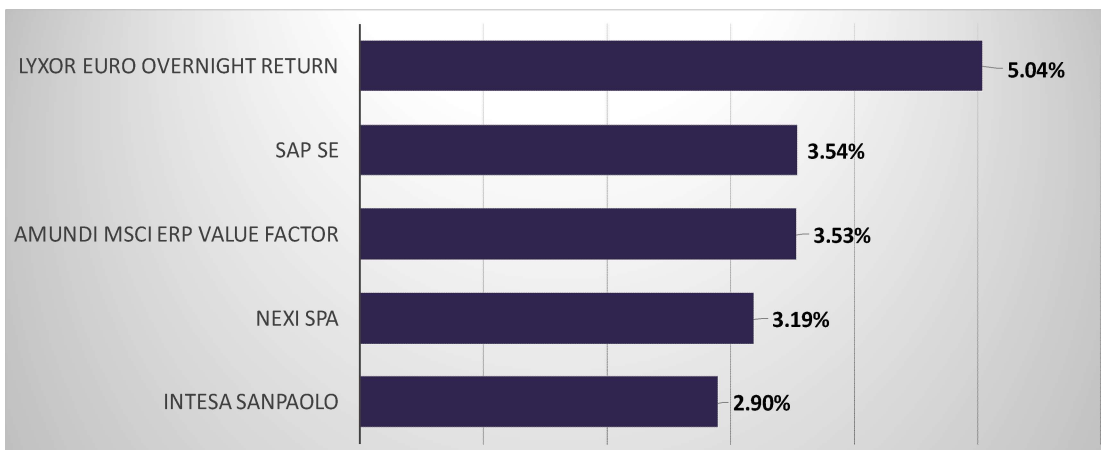


Asset allocation
