

Investment strategy

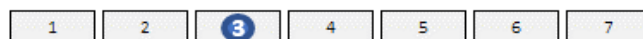

Cumulative performance since inception - net of fees

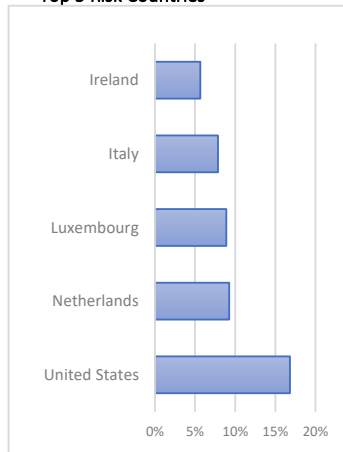
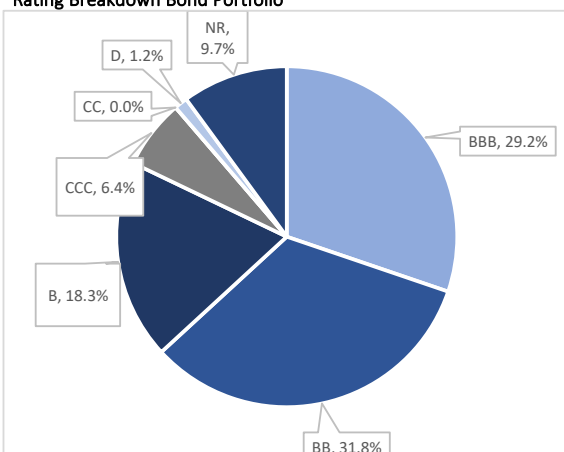
