Cumulative performance since inception - net of fees

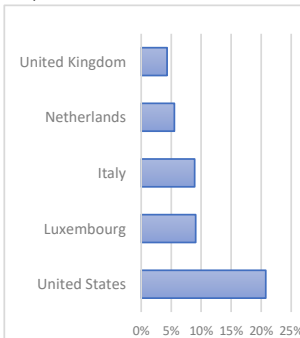
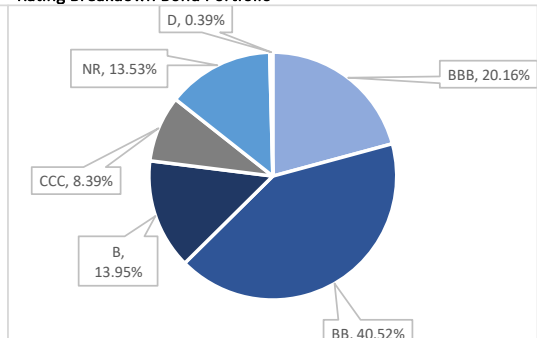
