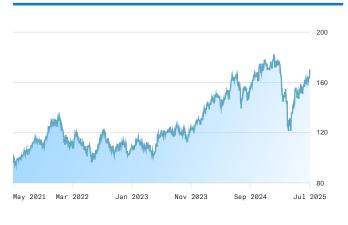

PRODUCT STRATEGY

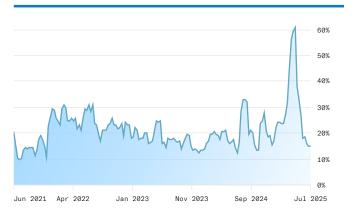

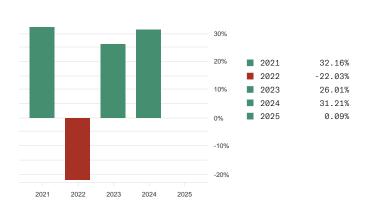

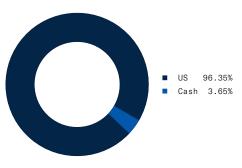
HISTORICAL VOLATILITY

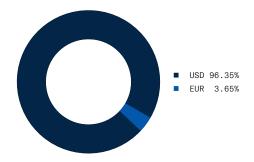

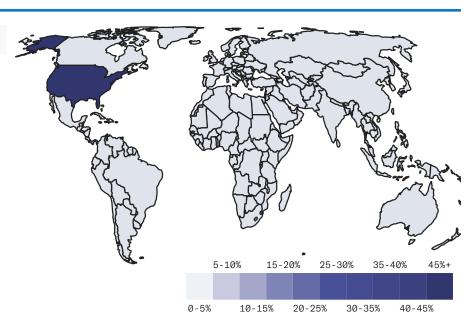
PRODUCT COMPOSITION BY COUNTRY
